3. The Manufacturer and the Agent are responsible for medical device vigilance and post marketing reporting of the product safety, quality and efficacy follow up after marketing.
4. The appointed agent(s) is responsible for correspondence and complete compliance with regulatory requirements pertaining to the product distribution life cycle in the country.
5. This agency agreement shall come into force as of its date of signature and remain valid until 30/08/2026 unless terminated by either party with a written notice at any time.
